



Summary of retail electric rates for 2017

Residential Service Rate: (Rate 01, 03)*

Residential Service rates apply to houses, single-family dwellings and apartments with one residence.

- Customer Charge - \$5.00 per month *(\$5.70 in 2016)*
- Facilities Charge per month
 - \$10.50 Level 1 *(\$7.70 in 2016)*
 - \$14.50 Level 2 *(\$7.70 in 2016)*
 - \$19.50 Level 3 *(\$7.70 in 2016)*
 - \$45.00 three-phase *(\$50.00 in 2016)*
- Energy Charge
 - Summer (June 1 - Sept. 30)**
9.56¢ per kWh for all kWh *(9.63¢ in 2016)*
 - Winter (Oct. 1 - May 31)**
6.43¢ per kWh *(7.01¢ for the first 30 kWh per day and 5.71¢ all else in 2016)*

Small Commercial, Non-Demand: (Rate 10, 13)*

Service rates apply to any nonresidential customer using less than 100 kW during the summer months.

- Customer Charge - \$6.50 per month
- Facilities Charge per month
 - \$16.60 single-phase *(\$14.25 in 2016)*
 - \$51.50 three-phase *(\$45.00 in 2016)*
 - \$28.50 primary *(\$20.20 in 2016)*
- Energy Charge
 - Summer (June 1 - Sept. 30)**
9.08¢ per kWh for secondary *(9.09¢ in 2016)*
8.80¢ per kWh for primary
 - Winter (Oct. 1 - May 31)**
6.06¢ per kWh for secondary *(6.13¢ in 2016)*
5.85¢ per kWh for primary *(5.90¢ in 2016)*

Small Commercial, Demand: (Rate 11, 12)*

General Service-Demand rates apply to any commercial service using more than 100 kW during the summer months, or more than 25,000 kWh per month.

- Customer Charge - \$25.00 per month
- Demand/Facilities Charge per month
 - \$14.90 per kW secondary
 - \$13.65 per kW primary
- Energy Charge
 - Summer (June 1 - Sept. 30)**
3.40¢ per kWh secondary
3.25¢ per kWh primary
 - Winter (Oct. 1 - May 31)**
2.57¢ per kWh secondary
2.40¢ per kWh primary

Heating Service Rate: (Rate 21)*

Heating Service rates apply to any commercial service with separately metered space heating and/or water heating.

- Customer Charge - \$5.30 per month
- Facilities Charge per month
 - \$18.65 single-phase *(\$15.20 in 2016)*
 - \$67.20 three-phase *(\$52.70 in 2016)*
 - \$179.95 large service *(\$169.70 in 2016)*
- Energy Charge
 - Summer (June 1 - Sept. 30)**
8.67¢ per kWh *(8.74¢ in 2016)*
 - Winter (Oct. 1 - May 31)**
5.17¢ per kWh *(5.23¢ in 2016)*

Large Commercial, Demand: (Rate 15, 16)*

Large Light & Power rates apply to any commercial service using more than 400 kW during the summer months, or more than 100,000 kWh per month.

- Customer Charge - \$275.00/month
- Demand/Facilities Charge per month
 - \$20.95 per kW secondary *(\$19.95 in 2016)*
 - \$20.01 per kW primary *(\$19.05 in 2016)*
- Energy Charge
 - Summer (June 1 - Sept. 30)**
2.85¢ per kWh secondary
2.75¢ per kWh primary
 - Winter (Oct. 1 - May 31)**
2.44¢ per kWh secondary *(2.37¢ in 2016)*
2.34¢ per kWh primary *(2.30¢ in 2016)*

Large Industrial: (Rate 44, 45)*

Large Power Contract rates apply to any industrial service using more than 4,000 kW per month.

- Customer Charge - \$550.00 per month *(\$500.00 in 2016)*
- Demand/Facilities Charge per month
 - \$20.55 per kW secondary *(\$19.25 in 2016)*
 - \$19.65 per kW primary *(\$18.30 in 2016)*
- Energy Charge
 - Summer (June 1 - Sept. 30)**
2.78¢ per kWh secondary
2.65¢ per kWh primary
 - Winter (Oct. 1 - May 31)**
2.30¢ per kWh secondary *(2.17¢ in 2016)*
2.22¢ per kWh primary *(2.10¢ in 2016)*

*In addition to these rates, a City Dividend applies to **all** kWh sold.

Customer service fees for 2017

New Account Service Fee

Applicable to every new account, move, transfer, etc., upon the request for service initiation (excluding accounts managed under landlord's agreement). \$25

Late Payment Fee

Applicable to all accounts for amounts not paid by the due date on or after the first business day past the due date. 3.0 Percent of Past Due Amount

Disconnect Charge for Nonpayment of Bill

Applicable *during* LES' normal office hours without use of an LES Operation's line crew. (8 a.m.-5 p.m. M-F not including holidays.) \$60

LES Operation's line crew required. \$110

Returned Payment Fee

Applicable to accounts when a customer's payment is returned to LES from a banking institution. \$30

Rereads

Applicable when LES returns to customer's service location to reread the meter at the customer's request. The charge applies when the original reading was *not* in error. \$20

Inaccessible Meters

Applicable when an attempt by LES to read or service an inaccessible meter is unsuccessful. \$75
